For applications made by correspondence, natural persons must submit the original copy of the certificate of seal/signature and the photocopy of the ID card or the original copy of the certification of identity (replaceable with the household certificate or the photocopy of the household registration transcript if under 14 years old, and the photocopy of the ID card of statutory representatives or parents if underage (under 18 years old) and the original copy of the household registration transcript. Legal persons (companies) must submit the original copy of the government documents. The original copy of the certificate of seal/signature must be issued within six months before the date of application. All applications must be delivered to:

To protect the rights and interest of the beneficiary, when reporting a lost seal, the originally authorized seal will be voided (except for the cancellation of pledge creation of original beneficiary certificates). After the completion of registration, the new seal will take effect on the same date, except with a special declaration.
